Macomb Pediatric Associates, P.C. will assist you by submitting claims to your insurance company. This does not, however, change the fact that as the parent, you have full responsibility to pay for all services rendered on behalf of your child.

Co-pays are expected at the time of service, along with any previous balances and you must follow up with your insurance carrier when instructed. Due to the many changes in insurance policies, it is no longer possible to interpret each individual policy, or for us to know exactly what your coverage will be. As the insurance holder, it is your responsibility to please check with your insurance company prior to any office visits, testing, immunizations, etc. **IT IS YOUR RESPONSIBILITY TO KNOW YOUR INDIVIDUAL COVERAGE.**

- 1) To keep our fees at a reasonable level, it has become necessary to collect payment at the time of service. Any co-pays and previous balances will need to be paid before services are rendered. If you have Master or Major Medical coverage, you must pay for the entire office visit at the time of service. We will be glad to submit the bill for you to the insurance company, and then you will receive payment directly from them.
- 2) We will create an insurance form and provide the same to your insurance company for your coverage including the payment from the procedures provided.
- 3) If hospitalization is required, we will generate the insurance claims necessary for our services during the hospital stay, submit them to the insurance company and assist you in collection. You will be responsible for all co-insurance and necessary deductibles.
- 4) If your insurance requires a referral, we require 24-48 hours prior notice, please call (586) 573-9231 for any and all services received outside of our offices. Failure to receive authorization could result in you being responsible for all costs incurred. If emergency treatment is received, please notify us within 48 hours for authorization.
- 5) Any overpayment made on your account will be applied to future treatment, copayments, or will be refunded to you at your request.
- 6) Special payment arrangements are considered on an individual basis. Please, contact a representative in the Billing Department at (586) 573-9231, as soon as possible to discuss all payment arrangements and any charges that you have questions about. We do charge a 5% late fee per month for all patient accounts that are over 30 days old. In the event that your account should be placed with a collection agency, there may be collection fees added to the total amount owed and all patients on your family account will be dismissed from our practice.
- 7) Patient/Guardian will be held responsible for any damage caused by the patient/guardian to Macomb Pediatric property and any equipment.
- 8) We are an immunizing clinic and unfortunately do not accept non-vaccinating

patients. Thank you for selecting us to be your child's health care providers.
